

Hart District Council (The Fleet Half Marathon)
(Temporary Road Closure and Temporary Prohibition of Traffic) Order 2017

WHEREAS Hart District Council (hereinafter referred to as “the council”), as the Traffic Management agent of Hampshire County Council, is satisfied that traffic should be restricted and prohibited on lengths of the under-mentioned roads for the purpose of facilitating the holding of a relevant event as defined by Section 16A(1) of the Road Traffic Regulation Act 1984, as amended by the Road Traffic (Special Events) Act 1994 and the Traffic Management Act 2004.

NOW, THEREFORE, the council in exercise of its powers under Section 16A(2) of the Road Traffic Regulation Act 1984, hereby makes the following order:

1. This order may be cited as Hart District Council (The Fleet Half Marathon) (Temporary Road Closure and Temporary Prohibition of Traffic) Order 2017 and shall come into force on 06.00 hours on Sunday 19 March 2017 and shall apply for a period of 12 hours.

2. In this order:

“bus stop” means an area of carriageway on a side of the road, intended for the waiting of buses, which is comprised within and indicated by a road marking complying with diagram 1025.1 in Schedule 7 to the Traffic Signs Regulations and General Directions 2016;

“taxi rank” or “taxi bay” means an area of carriageway on a side of the road, intended for the taxis, which is comprised within and indicated by a road marking complying with diagram 1028.2 and 1028.5 in Schedule 7 to the Traffic Signs Regulations and General Directions 2016;

“lay-by” means an area of carriageway, intended for the waiting of vehicles, bounded partly by a road marking on the outer edge of that carriageway complying within diagram 1010 in Schedule 11 to the Traffic Signs Regulations and General Directions 2016;

“loading area” means an area of the side or lengths of roads specified in Schedule A where activities other than loads are prohibited;

“disable parking bay” or “disable bay” or “parking bay” means a parking place or an area of carriageway on a side of the road, intended for the parking of vehicles, which is comprised within and indicated by a road marking complying with diagram 1028.4 and 1028.6 in Schedule 7 to the Traffic Signs Regulations and General Directions 2016

“event” means Fleet Half Marathon

“the event period” means a period of 6 hours starting at 09.00 hours on Sunday 19 March 2017

“a Fleet Half Marathon Marshall” means a person in a high visibility vest and cap clearly marked with Fleet Half Marathon or Fleet Lions

3. Subject as mentioned in articles 6 and 7 below, no person shall, during the event period, cause or permit any vehicle to enter or proceed in, or wait on or in any of the roads mentioned in Schedule A, and during the times indicated in Schedule A.
4. Subject to the provision of articles 6 and 7 below, no person shall, during the event period, cause or permit any vehicle to enter or proceed in or on those parts of the roads or cause any vehicle to proceed in a banned direction and from or to those roads mentioned in the Schedule A, and during the times indicated in Schedule A.
5. Subject to the provision of articles 6 and 7 below, no person shall, during the event period, cause or permit any vehicle to wait or stop in a disable parking bay or disable bay or parking bay or lay-by or taxi rank or bus stop or load/unload in a loading area on those roads mentioned in Schedule A, and during the times indicated in Schedule A.

6. The provision of article 3, 4 and 5 above shall apply only during Sunday 19 March 2017 and at such times and to such extent as may from time to time be indicated by traffic signs and signals, or directed by a Fleet Half Marathon Marshall.
7. Nothing in articles 3, 4 and 5 above shall apply to –
 - (a) A vehicle being used in connection with the said event;
 - (b) A vehicle being used for police, ambulance or fire and rescue authority purposes; or
 - (c) Anything done at the direction of, or with the permission of, a constable in uniform or Fleet Half Marathon Marshall
8. This order shall be in operation from Sunday 19 March 2017 for a period of 1 day or until completion of the relevant event whichever is the sooner.
9. This Order shall initially be in effect until 31/03/2017

Schedule A

1. A323 Reading Road North, Fleet between its crossroad junction with A3013 Fleet Road, A323 Reading Road South and Crookham Road and its junction with Tavistock Road. The road between these junctions will be closed from 9.00am and the road will be re-opened at approximately 2.00pm.
2. Tavistock Road, Fleet between its junction with A323 Reading Road North and its junction with Mervale. The road between these junctions will be closed from 10.00am and the road will be re-opened at approximately 11.00am
3. Mervale, Fleet between its junction with Tavistock Road and its junction with Lee Wood Road. The road between these junctions will be closed from 10.00am and the road will be re-opened at approximately 11.00am.
4. Lee Wood Road, Fleet between its junction with Mervale and its junction with Crookham Road. The road between these junctions will be closed from 10.00am and the road will be re-opened at approximately 11.00am.
5. Crookham Road, Fleet between its junction with Lee Wood Road and the crossroad junction of A3013 Fleet Road, A323 Reading Road South and Crookham Road and Tavistock Road. The road between these junctions will be closed from 10.00am and the road will be re-opened at approximately 12.00 noon.
6. A3013 Fleet Road, Fleet between its crossroad junction with A323 Reading Road South and Crookham Road and its junction with A3013 Cove Road. The road between these junctions will be closed from 10.00am and the road will be re-opened at approximately 12.00 noon
7. Stockton Avenue, Fleet between its junction with A3013 Fleet Road and its junction with Elvetham Road. The road between these junctions will be closed from 10.00am and the road will be re-opened at approximately 11.30am
8. Elvetham Road, Fleet between its junction with Stockton Avenue and its junction with A323. Reading Road North. The road between these junctions will be closed from 10.00am and the road will be re-opened at approximately 11.30am.
9. B3013 Minley Road, Fleet between its roundabout junction of the A3013 Fleet Road/Cove Road and its junction with Blackbushes Road. The road between these junctions will be closed from 10.30am and the road will be re-opened at approximately 12.00 noon.
10. Rotten Green Road, Fleet between its junction with Blackbushes Road and its connection with Pale Lane [east] at Doghouse Bridge [Doghouse Copse]. The road between will be closed from 10.30am and the road will be re-opened at approximately 12.00 noon.
11. Pale Lane [east], Fleet between its connection with Blackbushes Road at Doghouse Bridge [Doghouse Copse] and its junction with A323 Fleet Road. The road between these junctions will be closed from 11.00am and the road will be re-opened at approximately 12.30pm.
12. A323 Fleet Road, Fleet between its junction with Pale Lane [east] and its junction with Pale Lane [west]. The road between these junctions will be closed from 11.00am and the road will be re-opened at approximately 12.45pm.
13. Pale Lane [west], Fleet between its junction with A323 Fleet Road and its junction with The Hurst and Chatter Alley. The road between these junctions will be closed from 11.00am and the road will be re-opened at approximately 1.00pm.
14. Chatter Alley, Fleet between its junction with Pale Lane [west] and its junction with Church Lane. The road between these junctions will be closed from 11.00am and the road will be re-opened at approximately 1.15pm.
15. Pilcot Road, Fleet between its junction with Church Lane and its junction with Hitches Lane. The road between these junctions will be closed from 11.00am and the road will be re-opened at approximately 1.15pm.
16. Hitches Lane, Fleet between its junction with Pilcot Road and its junction with Fitzroy Road. The road between these junctions will be closed from 11.00am and the road will be re-opened at approximately 1.30pm.
17. Fitzroy Road, Fleet between its junction with Hitches Lane and its junction with Tavistock Road. The road between these junctions will be closed from 11.15am and the road will be re-opened at approximately 2.00pm.
18. Tavistock Road, Fleet between its junction with Fitzroy Road and its junction with A323 Reading Road North. The road between these junctions will be closed from 11.15am and the road will be re-opened at approximately 2.00pm.
